

#### 15.00

Guests are seated for your Wedding Breakfast and
Newlyweds are announced into the room

#### 15.30

Speeches and Toasts. Allow approximately
15 minutes for your speeches depending on the
number of speeches

#### 15,45

Wedding Breakfast. Allow approximately
90 minutes for you and your guests to enjoy
your first meal as a married couple

Guests depart for evening turnaround.

Evening Reception. Your night begins with your private bar open and DJ playing as your guests arrive

#### Terms and Conditions

#### BOOKING

We may agree to you making a provisional booking with us, but this is not legally binding on either you or the Hotel unless and until a contract is entered into and a deposit received.

Until we receive your deposit the booking is deemed provisional and we reserve the right to cancel your event.

When your date is agreed, it can be held for 14 days. A deposit of £500 must then be paid by cash or card to confirm the booking. Terms and conditions must be signed and returned at this time. Please note that your deposit will not be returned if you then decide to cancel your booking.

#### **DEPOSITS**

Your deposit and all further payments then received are non-refundable and non-transferable.

#### **PAYMENTS**

We recommend that you take out wedding insurance in the unlikely event of any unforeseen circumstances.

You must make payments of £500 every 6 months in the lead up to your wedding. Final numbers must be provided no later than 6 weeks prior to your wedding. The final payment must be paid no later than 4 weeks in advance of your wedding. Any reduction in numbers after this point will not be refunded.

#### CANCELLATION BY YOU

Cancellation of any part of the reservation should be advised to us verbally in the first instance. This must be followed up in writing and you will receive confirmation of the cancellation from us within one week. Your booking will not be released for resale until this process is complete. All monies paid will he lost on cancellation

#### **EVENT CANCELLATION**

The Hotel reserve the right to cancel the booking or reservation for the function in the event of the Client failing to perform any of its obligations herein.

Any costs incurred for a particular event, that otherwise would both have been incurred, will be charged in the event of a cancellation unless the Hotel is able to mitigate the cost, (eg. Audio equipment, staff booked, food, printing, décor etc).

#### NUMBERS IN ATTENDENCE

The Client must give final numbers to the Hotel when requested. The acceptance of any increase in numbers is at the discretion of the Hotel

The general content of your wedding package shall be as set out in your quotation, or as otherwise subsequently agreed with us in writing.

#### ALLOCATION OF FUNCTION ROOMS

The Hotel reserves the right to reallocate a function room to a room other than that originally designated.

We reserve the right to make changes to the interior and /or exterior of the venue between the time we accept your booking and the date of your wedding.

#### WEDDING PACKAGES

The Hotel reserve the right to make changes to certain components of your package if deemed necessary to abide by changes in safety requirements or law.

#### CLIENT RESPONSIBILITIES

It is your responsibility to book the Registrar for your wedding. We advise you to hold your date with us, then contact the registrar before confirming your booking with us. You must provide us, by the dates requested, any information we require such as menu choices and quest numbers so we can finalise your package and its price.

#### **FOOD AND BEVERAGES**

No food or drink is to be brought into the Hotel without prior permission from the General Manager. If your guests bring their own drinks onto the premises these will be confiscated on sight. Wedding cakes should be delivered to the Hotel on the morning of the wedding. If you wish to take remaining wedding cake away with you this must be done by 11am the following morning.

The Hotel reserve the right to change prices and menus without notice due to circumstances beyond our control.

We cannot guarantee the absence of nut products in our food. We will endeavour to meet all dietary requirements but we cannot quarantee that trace elements may not be present in the food.

Our menus are updated every six months and we will apply our inflationary rise on the 1st April. Additional bar tariffs are charged at the prevailing rate at the date of your final invoice and so subject to change.

We will always aim to seat your guests for your meal at a prearranged time but we cannot quarantee this.









































#### ACCOMMODATION

You will be provided, on confirming your reservation, with a booking code to distribute to your guests to allow them to book accommodation at a reduced rate. This code will only activate 12 months in advance of your wedding and will become inactive 14 days ahead of your wedding. All accommodation is subject to availability.

#### ARRIVAL AND DEPARTURE TIMES

Check in for Hotel bedrooms is 3pm. Check out is 11am. Late check out is subject to availability. Please consider these times if you or your guests are planning on getting ready at the Hotel. The only way to guarantee this is to book your accommodation for the night prior. This is also the case for the bridal party. All rooms are advance purchase and payment will be taken on booking.

#### FIRE EXITS

The Client shall ensure that all guests are aware of the entrance and spaces available for their guests and suppliers. Fire exits and walk ways must be kept clear at all times.

#### SPECIAL EFFECTS

The use of pyrotechnics and smoke machines are not permitted in the Hotel.

#### NOISE

The level of noise produced by sound equipment must be kept within reasonable levels at all times. Contracted persons and / or equipment for the playing of music must be pre-approved by the Hotel.

#### DAMAGE TO HOTEL PROPERTY

The Client shall take all reasonable precautions not to damage any Hotel property. The Client shall ensure that nothing shall be affixed to the floors, walls, ceilings or pillars of the Hotel unless with prior approval from the Hotel.

You will be liable for any damage you or your guests cause to the Hotel, its equipment, contents or fittings.

The Client will be notified as soon as possible after the conclusion of the event of any loss or damages to the Hotel property. The Client shall be debited for the total cost of repairing or replacing Hotel property that may have been damaged, broken, lost or stolen, even should the responsibility for this be attributed to someone the Client may have subcontracted

#### RIGHT TO EJECT PERSONS

The Hotel reserves the right to eject any persons from the function or the Hotel premises who it shall consider objectionable including any engaged by the Client to provide entertainment or perform any other duties at the function.

#### SUPPLY OF GOODS OR SERVICES

The Client agrees to pay the Hotel charges for any goods and services that have been provided by the Hotel at the request of the Client or any person acting on behalf of the Client and having authority to do so.

#### WASTE

No waste material such as packaging shall be left on the Hotel premises. The Client must ensure that any materials are immediately removed.

#### STORAGE AND SUPPLIERS

We do not provide any special storage rooms for any wedding items. It is the responsibility of the Client to make sure all items are removed from the Hotel. The Hotel is not responsible for any items lost due to the negligence of guests. Any items left behind from your event must be collected within 48 hours or will be discarded by the Hotel. We do not accept any liability for items belonging to the wedding party or suppliers under any circumstances.

All suppliers can access the Hotel on the day of the wedding from 9am. We cannot guarantee access prior to this. We do not take responsibility for flowers, cakes or any external décor brought to the Hotel prior to the day of the wedding.

#### VAT

All prices are inclusive of VAT. However, if the rate of VAT changes between the date the contract is formed between you and us and the date of your wedding, we will adjust the VAT you pay (and hence the overall price of your package), unless you have already paid for your wedding package in full before the change in the rate of VAT takes effect.

#### CIVIL LIABILITY

Subject to its liability under the Hotel Proprietors Act 1956 the Hotel will not be liable or responsible for any jewellery, luggage, clothing or other property of the Client brought onto the Hotel premises by the Client.
